#### 2.0 Reports

- **2.1 President (Tim Karas)** / President Karas briefly reported on status of CCC budget numbers in Governor's proposed 2015-16 budget.
  - **2.1.1 TTAC** / The three award proposals (Foothill, Butte) were reviewed. TTAC has its annual retreat at the end of May. The May Revise budget could bring additional \$ for technology.
  - **2.1.2 ACCJC Presentation** CCL submit comments as a group, on behalf of CCL, but recognizes need to work with and get supportive comments from institutions. Tim will also communicate with CCL members on the actual comment form and give suggestions on working with local academic senates, CIO, and the CEO; may use the ASCCC resolution passed in the Fall Plenary. Comments to the Commission are due April 30, 2014. CCL's accreditation standards work group (Tim, Andy, and Meghan) will reformat the previously submitted recommendations into the new comment form. President Karas will attend the Sacramento public hearing; Paula Paggi will represent CCL at the Sylmar meeting.
